8	<p>Seagreen Large Fund – Craig Mullen</p> <p>Community Council's affected by the Seagreen Windfarm have been awarded £9000 pa for 5 years for community micro grants.</p> <p>A large fund of £250K is available to our community council for a large legacy project, which may be split into 2 - 4 smaller projects, however would not support 10 -20 small projects.</p> <p>It is for the CC to decide which projects to put forward, and to gauge community views.</p> <p>It may be worth setting up a community panel to run to gauge community support in the applications which are received.</p> <p>Groups applying for the funding must be constituted.</p> <p>The dates for NOI's was extended to 31<sup>st</sup> March 2024, these will be for the CC to look at and share with the community to gauge what the community would like.</p> <p>The current NOI's received are from:-</p> <p>Ferryden in Flower  Montrose Sailing Club  Montrose Trinity Church of Scotland  North East Wellbeing Solutions  Rossie People's Young Trust  Save Montrose Basin Core Path</p> <p>Common Good Land –  Montrose Sailing Club &amp; Inch Pavilion &amp; Bowling Green  Both are within our ward but belong to Montrose Common Good.</p> <p>Seagreen could not authorise using the funding on land that does not belong to the ward.</p> <p>If the FCCC were to purchase the pavilion this would not be an issue. Montrose Sailing Club which is Montrose Common Good, might be more difficult.</p> <p>Ferryden have a Trust (FCCT) which is registered in Edinburgh and potentially could receive an asset transfer as a solution.</p> <p>Cllr Gall will ask AC legal dept for advice.</p> <p>Clarification on what won't be supported by the Fund:-</p> <p>Projects that don't support people within the CC area:-  The advancement of Religion or Politics  Purchase of fire arms  Cost of energy consumption  Repayment of Loans or Payment of Debts  Costs already incurred or activities which will take place before a decision has been made on the application  Payments towards areas generally understood to be the primary responsibility of statutory authorities  Anti-windfarm renewal activities</p>
